

AFDA By-Law Addendum  
Approved by the Board of Directors

\*\*\*\*\*ADDITIONS\*\*\*\*\*

ARTICLE II - DEFFINITIONS

Section 10 Whenever the word "dart" is used in these by-laws, it shall mean  
A projectile used in a game, contest or tournament play cannot exceed an overall maximum length of 12 inches/30.5cm, nor weigh more than 1.763 oz/50 gm per projectile. Each dart will consist of a recognizable point consisting of a steel or a solid metal composite, a barrel, a shaft and flights or feathers. All darts shall be thrown by and from the hand. An exception to the "thrown by and from the hand" may be made by the Tournament Directors and/or the Executive Board for a physical challenged member. Any requested exceptions must be in writing to the AFDA Executive Board or Tournament Director at least 10 days prior to any event.

Section 11 Whenever the word "dartboard" is used in these by-laws, it shall mean. The scoring board shall be a standard English 18" Bristle Board with the standard 1-20 English clock pattern of the type approved by the American Darts Organization and/or AFDA. Any future electronic or self scoring type dartboards must be approved by the Tournament Director and the Executive Board.

ARTICLE VII - BOARD DUTIES/QUORUM

Section 1 The board shall meet ~~quarterly~~ *yearly*

ARTICLE VIII - THE EXECUTIVE

Section 6 The Executive shall meet at the call of the President, in person, by telephone *or live video/internet conferencing*. The presence of three officers, in person, by telephone *or live video/internet conferencing shall constitute a quorum.*

ARTICLE X - MEETINGS

Section 1 The president shall submit a written agenda to all Board Members ~~at least one week before anytime prior to~~ the meeting is *being* convened.


Section 6 Unless otherwise specified, or in the case of emergency, meeting announcements must be *sent by regular mail, e-mail, text message* mailed at least fifteen days in advance of the meeting date for Board Meetings or ten days for Executive Meetings

ARTICLE XIV - STATEWIDE PLAYOFF AND TOURNAMENT

Section 1 There shall be conducted annually at ~~least~~ *least* one statewide *team format and singles playoff/tournament for Members who are in good standings* ~~dart associations.~~

ARTICLE XVII - EXPENSES

Section 1 Any Board member or officer, under the direction of the board or the Executive is to be reimbursed for all legitimate expenses incurred in the name of AFDA. ~~Board Members and~~ Executive officers attending meetings from out of town shall be reimbursed for gas mileage for the meetings.
